In regards to the adoption of the above-described dog to NORCAL Golden Retriever Rescue, Inc. (hereafter called NGRR), I/We, the undersigned, agree to the following conditions:

1. To assume all legal risks and obligations of ownership, and I/We agree to hold NGRR, its officers, its board members, its agents, and its volunteers harmless for any loss of, damage to, or injury to persons, animals, or property arising from or relating to the above described dog.
2. To agree that this dog will be neutered by _____, if not already done. I understand that the adoption is conditional and not final until this dog is altered. In the event I/We fail to alter this dog and provide proof of sterilization as performed by a veterinarian by the date specified above, full ownership of this dog will revert to NGRR upon demand by a NGRR agent.
3. To keep this dog in my possession and not give away, sell, or abandon it but to return it to NGRR if I relinquish custody.
4. To provide a safe, clean environment with a securely fenced yard.
5. To care for this dog humanely at all times and to provide necessary medical care.
6. To not permit this dog to be used for vivisection or experimentation.
7. To have this dog wear a collar and identification tag at all times and to have a current license.
8. To respect and comply with all applicable animal control laws and ordinances imposed by city, state, and federal governments.
9. To allow a NGRR representatives to inspect my home both prior and after adoption of this dog.
10. To attend a basic obedience class, or seek other professional training.
11. To pay the requested donation of \$_____ (payable to NGRR). I understand that this adoption donation is a contribution towards NGRR's work in caring for Golden Retrievers and is not refundable.
12. To give my permission for a NGRR agent to remove this dog from my custody if this dog is being neglected, abused, or has not been altered as agreed and entry for this purpose shall not constitute a trespass upon the premises occupied.

The good faith determination of NGRR as to whether or not this dog has been neutered in accordance with this agreement shall be final, binding, and conclusive to all parties, including me/us. No entry onto my/our premises or elsewhere undertaken by and agent of NGRR in the good faith belief that this dog is being neglected, abused, or has been altered shall be deemed a trespass or other form of improper entry.

IMPORTANT NOTICE: Every effort is made to place only healthy dogs; however, NGRR cannot guarantee the health of any dog adopted from us. NGRR assumes no responsibility for any medical bills incurred from a private veterinarian.
